BOARDING CONTRACT

This is a Contract between **BEDS-N-BONES, LLC** known as “**Pet Lodge**” and the pet “**Owner**”.

Pet Lodge agrees to exercise due and reasonable care, and to keep the lodge premises sanitary and properly enclosed.

The pet is to be fed as determined by the Owner and to be housed in clean, safe quarters.

All pets are boarded or are otherwise handled or cared for by the Pet Lodge without liability on Pet Lodge part for loss or damage from disease, theft, fire, death, runaway, injury, or harm to persons, other dogs, or property by said pet, or other unavoidable causes, due diligence and care having been exercised.

Owner agrees to pay to Pet Lodge \$27.00 (twenty-seven dollars) per dog; \$25.00 (twenty-five dollars) per dog for two or more dogs and must be of the same household; \$22.00 (twenty-two dollars) per cat; \$20.00 (twenty dollars) per cat for two or more cats and must be of the same household, per night for boarding service.

Owner agrees to pay to Pet Lodge \$18.00 (eighteen dollars) per dog; \$16.00 (sixteen dollars) per dog for two or more dogs for Doggy Day Care Service.

Owner understands and agrees that all pets checked-out after 12:00 p.m. will be charged for a full day’s stay.

Owner understands and agrees that checking in or out on Sunday will be charged for a full day’s stay.

Owner understands and agrees to pay service fees of \$25.00 for checks returned non-sufficient funds.

Owner understands and agrees to pay a Special Accommodations fee of \$75.00 (seventy-five dollars) for any pet checked-in or checked-out before and/or after normal business hours.

All charges incurred by Owner shall be payable upon check-out of pet(s).

Owner further agrees that Pet(s) shall not leave the Pet Lodge until all charges are paid to Pet Lodge by Owner.

Pet Lodge shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges resulting from boarding pet(s) at Pet Lodge.

If the pet(s) becomes ill or if the state of the animal’s health otherwise requires professional attention, the Pet Lodge in its sole discretion, may engage the services of a veterinarian of its choosing, administer medicine or give other requisite attention to the animal, and expenses thereof shall be paid by Owner.

By signing this contract and leaving his or her pet with Pet Lodge, Owner certifies that Rabies, Parvo, Distemper and Bordetella vaccinations of said pet are current.

It is understood by Pet Lodge and Owner that all provisions of this Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits. This Contract contains the entire agreement between the parties.
